Section of this Department is responsible for reservation of Persons with Disabilities is Multi Tasking Staff (MTS). The vacancies are filled up by Staff Selection Commission. Against 77 sanctioned posts, total 63 MTS are presently posted in the Department (Sectt.) out of which 1 is differently-abled (VH). As per rules, 3% of the total post is reserved for PWDs. This is included when vacancies are intimated to SSC.

- 2. The work allotted to differently-abled MTS employees is mainly related to secretarial assistance and almost all posts of MTS are suitable for them. However, the work is allotted to them according to their nature of disability. Also, the reservation policy for Differently-abled candidates is followed while filling up the vacancies in MTS grade.
- 3. In so far as formation of Committee for identification of posts is concerned, there is no necessity for any committee as per reasons given in para-2 above.
